

Registration for Mine Site Operators



Registration

Mine site operators need to register to work with ITEZZE by completing and returning this form and making the relevant payment in accordance with the instructions below. Registration does not involve any further commitment for mine site operators beyond the required payment (which offsets the cost of processing their application and designing a system for their mine). ITEZZE works with mine operators on a 1st come 1st served basis but may nevertheless at its discretion vary the order where it considers a particular mine site may represent a reference site with accelerated roll-out potential.

Please send your remittance (in USD) for the total shown above (plus 10% GST)* by EFT to the account specified in the panel opposite with your company name (as registered) and MRA number as the reference. The account holder is authorised licensee IT&ES Industries (Oz) Pty Ltd ABN 93 628 532 212 which will send a receipted GST invoice promptly on receipt of this form (duly completed) at the locked bag address overleaf. Payment and return of this form will complete the registration application subject only to payment of mine site and inspection costs. These will be invoiced separately at a later date on behalf of the site inspection company and are payable within 14 days from date of invoice. They are estimated to range from USD115,000 to USD130,000 (plus travel and GST as applicable) depending on mine site location.
